WHEREAS:

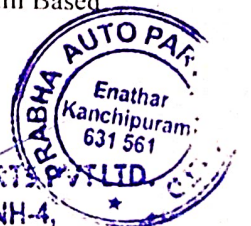
A) First Party is a Higher Educational Institution named Sir Issac Newton Polytechnic College.

CLAUSE 1

CO-OPERATION

RELATIONSHIP BETWEEN THE PARTIES

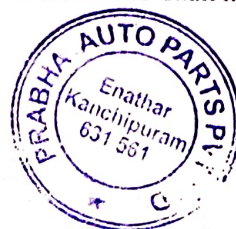
