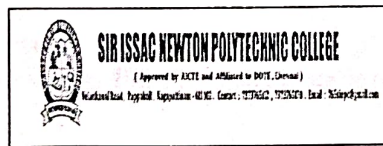

### MEMORANDUM OF UNDERSTANDING

**WHEREAS:**

- A) First party is a Higher Educational Institution named: SIR ISSAC NEWTON POLYTECHNIC COLLEGE,
  - B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
  - C) The Parties intent to cooperate and focus their efforts on cooperation within area of skill based Training, Education, Placement, Industrial Visit.

- NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

**CO-OPERATION**

**CLAUSE 1**

- 1.3 The parties shall co-operate with each other and shall as promptly as it responsibly practical, relevant agreement.

**SCOPE OF THE MoU**

**CLAUSE 2**

- 2.1 Industrial Training & Visits: Industry and Institution interaction will provide an insight into the latest development / requirement of the industries: the Second Party to permit the Faculty and Students of the development /requirement of the industrial: the second party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the First Party: This will provide confidence & smooth transition for students work. Also the second party may register on the AICTE Internship Portal for the benefit of the students.
- 2.2 Guest Lectures: Second party to extend the necessary support to deliver guest lecturers to the students of the First Party on the technology trends and in house requirements.
- 2.3 Placement of trained students: Second party will actively engage to help the delivery of the training and placement of the students of the first party on the technology trends and in house requirements.
- 2.4 There is no financial commitment on the part of the SIR ISSAC NEWTON POLYTECHNIC COLLEGE, the first party to take up any program mention in MoU. If there is any financial consideration, it will be dealt separately.
